

## IN SOLIDARITY FOR A BETTER FUTURE FOR YOUTH JUSTICE

7th December 2022

Dear Premier,

We write to you today regarding the state of youth justice in Western Australia.

The signatories to this letter are experts in justice, child wellbeing, youth affairs, lived experience, and community development. We comprise lawyers, community service providers, academics, Elders, Aboriginal Community Controlled Organisations, and more.

We have closely followed the emerging crisis in our youth justice system as details have emerged these past few months. In July, we saw the decision to send children to a maximum-security facility at an adult prison. In August, we heard the decision from the Supreme Court of WA declaring the confinement of children to cells for more than 20 hours to be illegal. In November, we watched with horror the footage from Four Corners showing dangerous and violent restraints used against children.

We stand in solidarity and unequivocal support of the <u>recent statement from</u> <u>Aboriginal leaders</u> from Western Australia. We echo their calls for a better approach for children and the closure of Unit 18 at Casuarina Prison. We believe Aboriginal people must be heard, and that the McGowan Government must engage meaningfully with the Aboriginal community and people with lived experience on youth justice issues.

We can both improve community safety and end the harm inflicted upon children in **prisons.** The evidence shows that to do this we must address the underlying causes of offending, and stop entrenching disadvantage. Interventions that help, not harm.

Currently, 50 per cent of young people entering detention in Western Australian will return within two years, increasing to 85 per cent after five years.<sup>[11]</sup> It is clear our approach is not working. Experts from all areas agree – our youth justice system has failed and must be reformed. Providing appropriate responses affords us the opportunity to reduce recidivism, increase community safety, and improve conditions for young people and staff in detention.

## We must both urgently intervene to safeguard children in detention and commit to a long-term strategy for our youth justice system that prioritises wellbeing, not punishment.

In August 2022, Social Reinvestment WA (SRWA) published its <u>Blueprint for a Better Future:</u> <u>Paving the Way for Youth Justice Reform in WA.</u> This evidence-based document outlines a comprehensive series of reforms to our youth justice system. We call on you to consider this <u>Blueprint</u> in reform of the youth justice system – we **have the solutions, and the evidence is clear**.



The way forward lies in trauma-informed and developmentally and culturally-appropriate care at every stage, investing in community and family-based responses, and providing the right support, at the right time, for every child.

We echo the calls from Social Reinvestment WA and stand with the statement released by Aboriginal leaders on Monday 28 November 2022 (which contains 6 asks of shared intent).

If we had been in attendance at the summit organised by the Premier, we would have asked the WA Government to:

1. **Investigate failures through an independent inquiry** that enables truthtelling and accountability for the behaviour uncovered by Four Corners across the entire system.

2. **Immediately ban use of dangerous restraints, solitary confinement,** and adhere to the WA Supreme Court ruling of maximum hours locked in cells.

3. **Commit to a specific date publicly to Close Unit 18** and transition children back to Banksia.

4. **Convene a taskforce of Aboriginal leaders, independent experts and Government** to develop and implement immediate changes within youth detention to improve the care provided to children.

5. **Commit to developing a whole-of-government Youth Justice Strategy** with direct Cabinet oversight, informed by the taskforce and the Blueprint developed by SRWA.

6. **Stop charging, prosecuting and locking up children under the age of 14**, who are not old enough by law to drive, vote, or get a job. Help them with tailored support instead of harming them.

We acknowledge the **recent decision to ban the use of 'folding up' in youth detention**, **and commend this first step.** However more must be done to immediately end harm of children in youth detention, and bring Western Australia in line with our human rights obligations.

We believe as a community we can do better, and seek your leadership on this issue.
